

# AGREEMENT ON JUDGE ACTIVITIES AT INTERNATIONAL DOG SHOWS

## 1. FCI- and VDH-Rules

The judge agrees to follow the FCI- and VDH-Regulations for Shows and Show Judges. Judgement is made purely on the basis of the FCI breed standards and/or the standard of national breeds recognised by the VDH. The duration of the duties will be determined by mutual agreement and in accordance with the rules of the VDH and the FCI.

**Through signing this agreement the judge assures that he is familiar with the relevant rules and with the breed standards and that he is authorized to judge the following breeds:**

The judge will receive the list of breeds he is designated to judge at the show three weeks before the show.

The judge may only be commissioned with additional breeds, competitions or final stages by the VDH by mutual agreement.

Written critiques are given in the ring, the show organizer will provide a qualified writer and ring steward.

## 2. Travel and other costs

The judge will be reimbursed accommodation and travel expenses incurred and supported by receipts in accordance with the VDH travel and expense regulations dated March, 1 2013 (see **Appendix 1**) which form part of this agreement.

The judge must prove expenses by providing invoices for reimbursement. Expenses are to be refunded in cash at the show.

The organizer will provide the judge with appropriate accommodation, meals and support beginning one day before (at the earliest) and ending one day following (at the latest) the agreed period of the judging activities:

- **Daily allowances: 35,00 EUR /day**
- **Travel Costs**  
Plane: Economy class/Rail: Fares for 2nd class will be refunded for distances of up to 200 km (per journey) and for 1st class travel beyond this distance. Any relevant supplements will also be refunded./Car: Where motorised vehicles are used, the sum of 0.30 Euros per kilometre will be refunded (shortest route).
- **Shuttle Service** respectively taxi costs to and from airport/railway station
- **Accommodation:**  -Star-Hotel
- **Meals: VIP-Service**
- **Accident insurance during the service as a judge on the show**
- **Other expenses (parking ticket, visa etc.)**

## 3. Cancellation

In the case that the judge is prevented from fulfilling his judging duties on account of illness or of any other exceptional circumstances, it is his duty to inform the organizer as soon as the reason becomes apparent and to provide relevant proof.

A conflict of appointments owing to other judging commitments the judge may have for the same date as the above mentioned dog show does not constitute exceptional circumstances in the sense of this agreement.

The organizer is entitled to cancel the agreement where there is good cause to do so.

This is in particular the case if the exhibition has to be cancelled or if the judge loses the authorization to carry out the activities listed under No. 1.

#### 4. Limitation of Liability

The judge is liable to the organizer only for damage caused deliberately or on account of gross negligence.

#### 5. Place of Jurisdiction, German Law

The place of jurisdiction is the registered office of the organiser in  . German Law shall be applied. Inasmuch as an issue is not specifically regulated within this agreement, the rules of Contract Law (§§ 662 – 676 BGB) shall be applied.
